INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT

- 1. The Environmental Management Bureau, CARAGA Region-XIII, through General Appropriations Act of FY 2020³ intends to apply the sum of One Million Seven Hundred Twenty Thousand Pesos (Php 1,720,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of ICT Equipment. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Environmental Management Bureau, CARAGA Region-XIII now invites bids for the Supply and Delivery of ICT Equipment.⁴ Delivery of the Goods is required within thirty (30) days upon issuance of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from EMB-XIII Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below during office hours, Monday to Friday from 8:00am to 5:00pm excluding holidays.
